INFORMATION CLAUSE FOR DATA DURING TICKET SALES

In accordance with Article 13(1-2) of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data and the repeal of Directive 95/46/EC - General Data Protection Regulation (Official Journal of the EU L 119, p.1), hereinafter referred to as "the GDPR", we would like to inform you that:

- 1.The controller of your personal data is Public Transport Authority in Lublin (Zarząd Transportu Miejskiego w Lublinie), ul. Nałęczowska 14, 20-701 Lublin, tel. 81 466 29 00, e-mail: ztm@ztm.lublin.eu
- 2.We have appointed a Data Protection Officer who can be contacted for the protection of your personal data by e-mail at odo@ztm.lublin.eu; or by calling 81 466 29 24.
- 3.Your data will be processed in order to lend the Electronic Ticket Card, as well as to conclude and perform a contract of carriage, i.e. issue the Electronic Ticket Card, encode the tickets and keep their records and archive for the purpose of possible protection of your and our claims under the contract of carriage. The legal basis for the processing of data is Article 6(1)(b) of the GDPR.
- 4.Your data resulting from lending the Electronic Ticket Card and from the conclusion of a contract of carriage shall be processed for 5 years from the date of expiry of the last contract coded on the Electronic Ticket Card.
- 5.Depending on where you file an application for an Electronic Ticket Card, your data will be automatically disclosed at that place and the entity that collects data on our behalf on the basis of an appropriate data entrustment agreement will process it in order to provide us with your data. Data may also be disclosed to our customers, in particular to law firms and IT service providers.
- 6.In accordance with the GDPR, you have the right to demand from the controller: the restriction of processing, the right to transfer data, the right to access your data and receive copies thereof, the right to rectify (correct) your data and to delete it – if such a right turns out to be justified.
- 7.You have the right to lodge a complaint with the supervisory authority if, in your opinion, the processing of your personal data violates the provisions of the EU GDPR. The supervisory authority shall be the President of the Office for the Protection of Personal Data.
- 8.The provision of data is not obligatory, but it is a condition for concluding a contract. Failure to provide data will make it impossible to conclude a contract of carriage and lend the Electronic Ticket Card.
